## Mountain-conquering Swiss family drops in for birth stop

# Third child may be named Cairns

A SWISS family sailing the world and etching their names into history want to include a special chapter for Cairns with the birth of their third child
Dario and Sabine Schwoerer have spent seven years travelling the globe, intending to visit every continent where they will bike to the highest mountain - sleeping in tents along the way - before hiking to its peak.
Their seven summits adventure has seen them climb Europe's Mont Blanc, South America's Aconcagua and Australia's Mt Kosciuszko.
When the trip is complete in another seven years time, the Schwoerers say they will be the only people to achieve the mountaineering challenge using natural energy. Three years into the expedition Sabine gave birth to Salina, 4, and then Andri, 2, who both stay in the care of local volunteers while their parents tackle the terrain.


Now the family of four, who have visited 40 countries during their trip, has earmarked Cairns to be the birthplace of their third child. "We might even name it Cairns," said Sabine, who is 32 -weeks pregnant. The pair, expecting the baby in two months, spend their spare time visiting schools telling adventure stories and promoting clean environment methods.
But Cairns could miss its chance to play a role in the adventure with
the Schwoerers saying they will leave for Darwin soon if schools show no interest.
"If we get a big response from schools we could stay and have the baby in Cairns," Dario said.
Everything on the family's boat is run by solar power and they pay for food and other running costs through sponsorship money and occasional part-time work.

# Stimulus plan Tax bonus payments 

## Last days

You must lodge your 2007-08 tax return by 30 June 2009 or you could miss out
To be eligible for the tax bonus payment you must lodge your return by 30 June 2009, unless we have granted you a deferral.

## How do you lodge?

You can lodge by mail using TaxPack or through a tax agent/ accountant. TaxPack is available from our shopfronts or you can download it at www.ato.gov.au

## How will we pay you?

We will transfer the payment into the bank account or mail a cheque to the address nominated in your tax return.

## Are you eligible?

Check www.australia.gov.au/taxbonuspayment
Have you lodged your 2007-08 income tax return?
Did you lodge your 2007-08 tax return after the end of March 2009?
You can expect your tax bonus four weeks after receiving a letter from us containing your notice of assessment.
Were your bank or address details correct?
We sent payment to the bank account or address nominated in your 2007-08 tax return. If these details were incorrect you need to phone us on 1300686636.

Is the payment with your tax agent/accountant?
If a tax agent/accountant completed your 2007-08 tax return, we may have sent your payment there.
